Terms & Conditions:

1. Tender documents can be collected from LPP office-Multan from 9:00am to 5:00 pm, Monday to Friday, **January 23, 2026**. The tender pack can also be down loaded from our website <https://lpp.org.pk> or sending email to procurements@lpp.org.pk.
2. Sealed tenders should reach **Procurement Department, Bangalow # 2, Opposite WAPDA Town, Gate No. 1, Near Multan Public School Road, Multan** on or before **12:00pm January 30, 2026** and should be clearly marked "**TENDER LPP/CWW/002/2026**" - Not to be opened before **01:00pm January 30, 2026**.
3. Tenders will be opened on the same day i.e. **01:00pm January, 30, 2026** in the presence of suppliers or their representatives, who wish to witness the tender opening.
4. In case a public holiday is announced by the Government (Due to any reason), the tender will be opened on the next working day at the same time and venue. Or will be informed to suppliers for opening session.
5. The prices should be inclusive of all type of taxes, delivery/transportation, packing, loading/unloading and with all other allied costs up to the point of delivery
6. The prices must be in Pak Rupee inclusive of all applicable taxes. Tax will be deducted at source as per Govt. of Pakistan tax law / FBR's updated guidelines.
7. 5% bid security (pay order / demand draft) of the bid amount must be submitted with the tender documents in favor of "Lodhran Pilot Project".
8. The Supplier must quote only one option for each item. Bids received with more than one options and rates may be rejected.
9. Bidders may apply for a complete single or multiple Lots.
10. Tender committee reserves the right to change the quantities or cancel/reject any or all offers without assigning any reason. The committee also reserve the right to divide the lots to different vendors.
11. Suppliers must not be engaged in any corrupt, fraudulent, collusive or coercive practices including but not limited to applying/ bidding by multiple names / companies. If any bidder is found to be involved in such practices his/her bid may be rejected and the companies in question permanently black listed.
12. Lowest price will not be the sole criteria; quality, delivery time, financial capacity and previous experience will also be considered.
